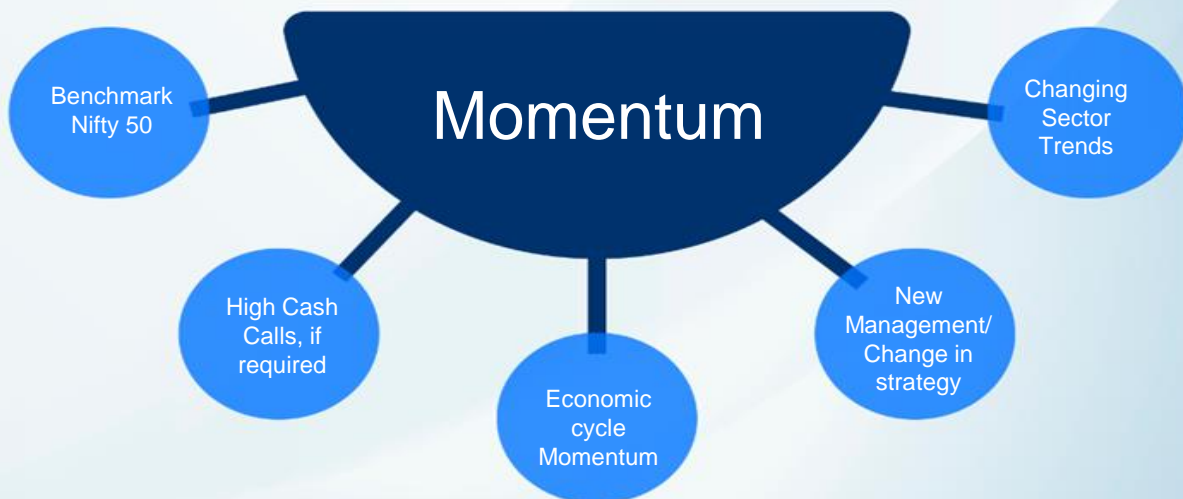


# ALPHA MOMENTUM

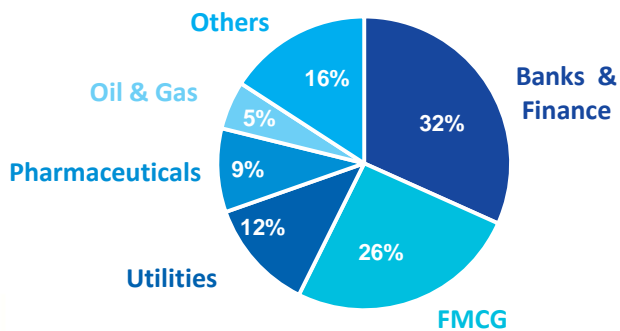

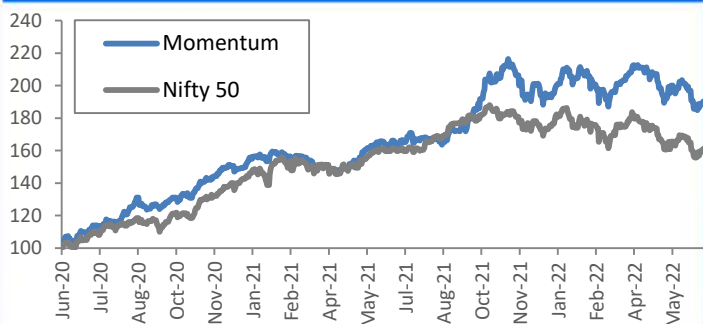
